Note :

Components listed as compliant with a RoHS version 1 (RoHS directive 2002/95/EU\_RoHS ) are also compliant with the RoHS directive 2011/65/EU\_RoHS because the only difference between this two directive is the scope of the directive (the hazardous substance and the required level are identical).

Components listed as compliant with a RoHS version 1 or with a RoHS version 2 are also compliant with Amendment 2015/863/EU. This amendment includes 4 new substances (phthalates) and, after analysis of the materials, they are only present in flexible plastic PVC and are not, to our knowledge, present in other types of materials.

As the components analyzed in this document do not contain any flexible PVC plastic, they are also compliant with amendment 2015/863/EU.

Related to this short risk analysis, components listed as compliant with a RoHS version 1 or version 2 are also conformed with RoHS version 3.
