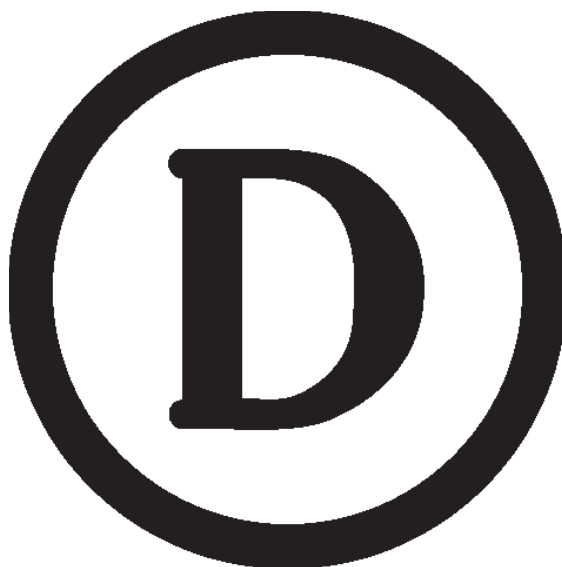

Certification Mark D-Mark
