Manufacturing

These products are manufactured by a site that has received an environmental certification ISO 14001.

This phase takes into account raw materials, manufacturing processes, production outcuts and their end-of-life treatment, upstream transport of materials and sub-assemblies to the manufacturing site, and transport from the manufacturing site to the final logistics platform.

Distribution

The packaging has been designed in accordance with current regulations. In particular, the European directive 94/62/CE relative to packaging and packaging waste.

The used packaging is 100% recyclable or recoverable. Packaging and logistic flows are continuously improved in order to reduce their impact.

This phase taken into account the transport of the finished product, including packaging, to its place of use.

Considering the complexity of the recycling channels for electric and electronic equipment impacts, we rely mainly on ESR modules (datasets for WEEE product end of life).

The recycling potential of the product is: 25%. The calculation of this rate is based on the method of the IEC/TR 62635.

Environmental impacts

Evaluation of the environmental impact covers the following life cycle stages: raw materials + manufacturing (RMM), distribution (D), installation (I), use (U) and end of life (EoL). An impact of 0 means that this impact represents either less than 0.01% of the total life-cycle impact of the reference stream, or no impact at all, when the global impact is zero.

All calculations are done with EIME software Version 6.3.2-4 with the database Version CODDE-2025-04.
